*Applicants need to provide 2 referee reports. The applicant would need to enter the referee's email address via the application system. The system will send a request to your referees to complete a series of question via the link provided by the system.*

*There is no preference for the referees (Academically/ Professionally)*
  
- Copy of Financial Statement\***

*Successful international applicants would need to show proof of having sufficient funds for the normal duration of the MSBA programme, after accepting the admission offers. Currently, the calculation of the required amount is based on \$18,000 per year for living expenses, in addition to the tuition and miscellaneous student fees.*
  
- Sponsorship Letter (if applicable)\***

**Please note the following:**

### **GRE or GMAT scores**

**Either a GRE test or a GMAT test is required for admission, except for graduates from local universities – NUS, NTU, SMU and SUTD – with degrees in Science, Mathematics, Statistics, Engineering, Computing, Business or Economics.**

**Strong quantitative analysis ability (as evidenced by either a superior GRE / GMAT quantitative section score or good grades in mathematics modules taken in the above-listed local universities) will be emphasized.**

### **Scholarship**

#### **➤ Business Analytics Centre (BAC) Scholarship**

Since Academic year 2015/2016, the NUS Business Analytics Centre has offered BAC Scholarships, valued at S\$10,000 and above, for exceptional full-time and part-time local candidates in their pursuit in the MSBA programme.

No bond is required for the scholarship recipients.

#### **Eligibility criteria:**

- Either a Singaporean or a Singapore Permanent Resident
- Excellent academic results or clear leadership at workplace

#### **Application:**

No application is required.

#### **Selection Process:**

Eligible candidates will be considered for scholarship during the Admission interview. No special interview session for the purpose of scholarship application is required. In normal cases, selected candidates will be informed of the scholarship decision together when they receive the offer of MSBA admission by the Centre. They are required to formally accept the offer before specified deadlines.

➤ **Ministry of Health Holding (MOHH) Scholarship**

**Local applicants (Singaporean or Singapore permanent resident) who are admitted to MSBA programme and interested in Healthcare Analytics areas are eligible to apply for MOHH Scholarship.**
